PARKING ON STREETS

We have received multiple concerns regarding the parking of campers, recreational and business trailers, boats, and similar vehicles on residential streets within city limits – full and dead-ended streets are included. Please be advised that this type of parking is not permitted, whether the vehicle is parked fully or partially on any city street.

Understanding that it may take some time to relocate these items, we are providing this notice as an opportunity to do so voluntarily. Official notices will be sent directly to the property owners or responsible parties if the items remain in violation.

We appreciate your prompt attention to this matter and your cooperation in helping maintain the safety and appearance of our community.

Ordinance 200

Declaration of nuisance. *The outside parking and storage on residentially zoned property of large numbers of vehicles and vehicles, materials, supplies, equipment, or farm machinery not customarily used for residential purposes in violation of the requirements set forth below is declared to be a public nuisance because it: (1) obstructs views on streets and private property, (2) creates cluttered and otherwise unsightly areas, (3) prevents the full use of residential streets for residential parking, (4) introduces commercial advertising signs into areas where commercial advertising signs are otherwise prohibited, (5) decreases adjoining landowners' and occupants' use and enjoyment of their property and neighborhood, and (6) otherwise adversely affects property values and neighborhood patterns.*

Section 5.10. Recreational Vehicles. *The storage and use of recreational vehicles within the City shall comply with this Section.*

Subd. 4. Prohibitions. The following uses of recreational vehicles are prohibited:

- (a) Street Parking. The parking of a recreational vehicle on a street for more than 48 consecutive hours;*

REMINDER - From Parking Ordinance No. 157:

- 1. General Parking Prohibition. No motor vehicle shall be parked on any public street for more than 48 continuous hours.*
- 2. One of the following: trailer, boat, recreational vehicle, or camper shall be allowed to be parked on any residential parcel provided it is not parked on grass or surface composed of other plant material and is located behind the front yard building line. Any such item must be parked on a hard surface of a uniform nature that encompasses the entire length and width of the vehicle/boat/camper/trailer and not in the front yard.*
